AAUW of Michigan 91st Annual Convention April 27th – 28th, 2013 Weber's Inn – Ann Arbor, Michigan Theme: *AAUW of Michigan – working to empower women.*

AAUW of Michigan President Janet Watkins called the business meeting of the AAUW of Michigan 91th Annual Convention to order at 2:00 p.m. on Saturday, April 27, at Weber's Inn in Ann Arbor.

AAUW of Michigan secretary Sally Doty read a letter from JoAnne Snell, AAUW MI president, 1979 – 1981, expressing regret that she could not attend, but congratulating the organization for the proposed convention.

AAUW of Michigan secretary called the roll of the branches; 26 branches were represented.

President Watkins introduced past state presidents: Harriet Sawyer, Barbara Bonsignore, Meg Brown, Ruth Brown, Mickey Edell, Kathy Shaw and Sally Doty. Seated at the front table were Sally Doty, secretary; Elizabeth Haynes, parliamentarian, and Phyllis Swonk, timekeeper.

President Watkins introduced the chairs of the convention committees and their committees: Laurie Gabel, tellers; Joan McGlincy, pages, and Sharon Belobraidich, registration and credentials.

Chair of the Credentials Committee Sharon Belobraidich read the first Credentials Report: nine members of AAUW of Michigan board; two past presidents; no chairs of convention committees; two college/university representatives; no members serving as AAUW officers/committees; 23 branch presidents or their delegates; 61 voting branch delegates for a total of 97 accredited delegates. Also attending were 57 non-voting members and 14 guests for a total of 71 non-voting delegates. Total convention attendees: 168. The report of the credentials committee was adopted and a quorum declared.

Secretary Doty moved to adopt the Rules of Order, and the Convention Rules were adopted.

President Watkins moved the adoption of the agenda as printed in the State Convention Book. **The agenda was adopted.**

President Watkins referenced the Minutes of the State Convention of 2012 found on pages 6 and 7 of the 2013 convention book. These minutes were approved by the state board at the July, 2012 Board Meeting. The Minutes of this state convention will be referred to the AAUW of Michigan Board of Directors for approval. **Hearing no objection the Minutes will be approved by the board.**

Reports of the officers are found on pages 26 – 33.

Reports of the finance vice-president: Finance Vice-president Polly Pan presented the financial statement and budget summary through March 31, 2013 found on pages 18 – 24 in the 2013 convention book. There were no questions. **The finance vice president's report was filed for audit.**

Finance vice president Polly Pan brought forth discussion about the motion presented in the AAUW Spring 2013 Newsletter. Moved that the annual AAUW MI dues be increased by \$2 from \$10 to \$12 beginning in fiscal year 2014-15. The motion was adopted.

Vice-President of Membership, Mary Mostaghim, delivered awards to the following branches: Largest percentage of increase 50% is the Detroit Branch; second was Lansing with a 25% increase. For the most new members, Ann Arbor with 30 came in first, followed by Birmingham with 19. Three other branches were recognized for large numbers and large percent's: South Haven has 22 new members for 19%. Battle Creek has 20 new members for 17%. Dearborn has 17 new members for 8% growth.

AAUW Funds Director, Mickey Edell, thanked all of the branches for giving more than \$98,432 to AAUW Funds. Her report is found on page 33 of the 2013 Convention book. She recognized the branches listed in her report and gave out certificates to the top ten branches in total contributions and the top ten branches in per capita contributions.

Sally Doty, Chair of the Resolutions Committee, presented the report found on pages 34 and 35 of the 2013 program book and declared that two resolutions listed in the Convention booklet [Statement of Policy – Society and Education (1968) and Resolution in support of Public Education (2003)]I are considered "current": She also reported that the other five [Statement of Policy – Higher education: encouragement (1963); Statement of Policy – Discrimination (1963); Statement of Policy – Women: Election and Appointments (1963); and Resolution: Clean air and water (1975)] are considered historic. She also presented **the Courtesy Resolution and moved its adoption. The Courtesy Resolution was adopted.**

Betty Chenoweth presented the report of the Bylaws Committee found on pages 36 – 39 of the 2013 Program Book. The committee brought forward 3 amendments to the bylaws. The first was to clarify the nominating committee selection and terms of office. The committee moved to amend Article VI. Nominations and Elections. Section 1 by adding new subsection 4: nominating committee members may serve only two consecutive terms. Motion Passed.

The second amendment was designed to update the list of state appointed officers. The committee **moves to amend Article VII.** Officers by deleting in section 3 "The appointed officers of AAUWMI...as needed" and substituting The appointed officers of AAUWMI may include "The *AAUWMI Newsletter* Editor, Directors for Branch Liaisons, Bylaws & Policies, College/University Relations, Communications & Marketing, Diversity, Initiative, Public Policy, and Technology & Website."; by adding a new concluding sentence "Appointed officers shall serve for a term of two years and shall be eligible to serve for two consecutive terms in the same office," And by inserting new Section 4: "The voting members of the Board of Directors of AAUWMI are the Elected and Appointed Officers named in Article VII." Motion Passed.

The third amendment clarifies the members of the board of directors. **The committee moves** to amend Article VIII by adding the words "named in Article VII. And non-voting members, Parliamentarian and State Servies Manager" after "AAUW MI." Motion Passed.

The meeting was recessed by President Watkins at 2:50 p.m.

The meeting reconvened at 12:10 p.m. on April 28th.

The second Credentials report was presented and adopted without objection.

Kathy Shaw, Nominations Committee Chairperson, presented the slate for 2013 – 2015. The nominee for President Elect is Elizabeth Haynes. The nominee for Membership VP was nominated by the Nominations Committee from the floor, because they were not able to confirm her nomination prior to the 30 day requirement. The nominee for Membership VP is Penny Larsen, Ed. D. There is no nominee for Finance VP. There were no nominations from the floor; **President Watkins declared the nominations closed, and the slate was elected.** As no one has been elected to the office of Finance VP, the office becomes a vacant position and will be filled by a vote of the board of directors as detailed in Article VII, section 1, d.

Reports of the Directors are in the convention book.

Public policy director, Barbara Bonsignore, referred to her report and encouraged the members to pick up copies of the *Citizen's Guide to State Government* (2013–2014) and the *Congressional Voting Record of the 112th congress, 2011-12* published by the AAUW Action Fund.

The other directors referred to their written reports and had no other information. Kathy Shaw did add to her report by asking the membership to nominate qualified candidates for Finance Vice President.

As an introduction to the AAUW Michigan Speech Trek program Doree Miller, Initiative Codirector, showed a video of one of the AAUW California speech trek finalists. She stated that today's speakers will be tomorrow's leaders. She explained the program and asked if any more branches would be interested in piloting the program using the theme, "Women at the Top: Why So Few?" The final competition will be held at the 2014 AAUW Spring Convention. The three branches that are working on this program presently are Dearborn, Escanaba and South Haven. Flyers were distributed to attendees.

Carmelitta Tiffany, Technology & Website director, encouraged more participation in the AAUW MI Facebook page and offered help to members for both facebook and the new website.

Reports of the coalitions found on pages 55 – 59 were referenced, Michigan for Public Education, Council about Parochaid, Pay Equity Network, and Michigan ERAmerica.

There was no unfinished business.

There was no new business.

There were no resolutions from the floor.

AAUW Executive Director Linda Hallman installed the new officers. She discussed the importance of the positions and emphasized that they need the members' support in order to lead successfully.

President Janet Watkins gave her closing remarks.

The meeting adjourned at 12:45 p.m.

CONVENTION RULES ARTICLE. V. MEETINGS OF AAUWMI

Section 1. Time, Place and Notification

- **a.** AAUWMI shall hold at least one regular meeting each year at the state convention to conduct the business of AAUWMI, including the election of officers and the receiving of reports of officers and committee chairs.
- **b.** The time and place shall be determined by the AAUWMI board of directors.
- c. Special meetings may be called by the president, on the written request of a majority of the members of the board of directors.
- **d.** Written notice of meetings shall be sent to all members of AAAUWMI at least thirty (30) days prior to the meeting. Notice shall include time, place and purpose for the meeting.
- e. All AAUWMI meetings, including meetings of the board of directors, shall be open and may be attended by any member.
- f. If circumstances prevent the holding of an AAUWMI meeting, the board of directors shall provide for the conducting of necessary business.

Section 2. Representation

- a. Voting Body The voting body of any meeting of AAUWMI shall be composed of:
 - 1) State Representatives including the following:
 - a) The members of the board of directors, including chairs of all standing committees.
 - b) Past presidents of AAUWMI.
 - c) The following convention committee chairs: Nominating, Resolutions, Credentials, Tellers, and Pages
 - d) Representatives of College/University Partner Members.
 - e) AAUWMI members serving as national AAUW officers or on national AAUW committees.
 - 2) Branch Delegates including the following:
 - a) The president of the branch or her/his designated alternate.
 - b) One delegate for each 25 members of each branch or major fraction thereof. Representation shall be based on the records of AAUWMI finance vice president as of February 1. Each branch shall be entitled to at least one such delegate.

3) Other Delegates

One delegate appointed by the state president for each 25 paid-up AAUWMI members who are not represented in the branch delegations

- **b.** Voting. A member of the voting body shall cast no more than one vote.
- **c. Quorum.** A quorum of an annual meeting of AAUWMI shall be 25% of members eligible to serve as delegates and attending, provided one-third of the branches are represented. This quorum shall include two elected officers of AAUWMI.

ARTICLE XII. RESOLUTIONS

Section 2. Resolutions

- **a.** Resolutions from branches or individuals shall be submitted in writing to the chair of the resolutions committee at least sixty (60) days prior to the annual meeting, the specific date to be set by the state president. The chair shall report to the members of the committee all resolutions submitted.
- b. The resolutions committee shall be empowered to reject any resolution which is in conflict with AAUW or AAUWMI bylaws, combine and/or consolidate resolutions of similar import, make editorial changes, make suggestions for implementation, report to the AAUWMI board the committee's approval or rejection of the proposed resolution(s), and initiate and propose courtesy resolutions.

- **c.** The resolutions committee shall report their recommended resolutions to the board for its approval. The board shall report the recommended resolutions to the branches at least forty-five (45) days prior to the annual meeting.
- **d.** Resolutions shall be adopted by a majority vote of eligible voters present at an annual AAUWMI meeting where a quorum is present.
- e. The resolutions committee shall review an adopted resolution every five (5) years on its anniversary date to determine if it is "current" or "historic" and report its status to the membership at the annual AAUWMI meeting.
- **Section 3. Resolutions from the Floor** Resolutions may be proposed from the floor, provided each resolution is permitted by a two-thirds vote of the delegates attending a meeting in which a quorum of eligible voters is present; a three-fourths vote shall be necessary to adopt a resolution from the floor.

PRIVILEGES OF THE FLOOR:

- A. The convention shall be open to all members and visitors. Only accredited delegates shall be entitled to offer motions and resolutions from the floor, debate, and vote.
- B. All accredited delegates shall be seated in the voting section.
- C. Any accredited delegate desirous of speaking shall first rise, address the chair, state her/his name and branch if applicable, and obtain recognition from the presiding officer.
- D. No accredited delegate shall be allowed the privilege of the floor a second time, to speak on the same question, as long as any accredited delegate who has not spoken to that question wishes to speak. This rule does not apply to the chair of a committee making a report, or to the speaker presenting a subject. These persons shall have three minutes for closing debate without the consent of the convention.
- E. No one may speak longer than three minutes at a time without the unanimous consent of the convention. A signal shall be given at one minute and at thirty seconds before the time limit of each speaker has been reached. The ruling of the timekeeper shall be strictly adhered to.
- F. During debate an effort will be made to alternate between supporting and opposing arguments.
- G. Debate will be limited to thirty (30) minutes on those items requiring a vote.

MOTIONS:

All motions shall be submitted in writing on motion forms, available from the pages. One copy shall be given to the secretary and one copy shall be given, to the presiding officer. Each shall be signed by the maker of the motion, stating his/her branch if applicable and delegate status.

CHANGES IN DELEGATE/CREDENTIAL STATUS:

- A. All changes in credentials shall be made at the Credential Desk.
- B. An alternate assuming delegate status shall wear her/his own convention badge in addition to the delegate's badge. In this case, the alternate shall be seated in the voting section and shall be allowed to present motions, debate, and vote.

AAUW OF MICHIGAN Proudly Presents the Martha Griffith's Equity Award To Jean Ledwith King

Beginning in the late 1960s, Jean Ledwith King, an attorney, has fought for women's rights in the political, legal, educational, and athletics areas. Politically active, King in 1970 along with five other women began the Women's Caucus of the Michigan Democratic Party and chaired that group for three years. A pro-choice advocate, she co-chaired the *Michigan Abortion Referendum Campaign* in 1972. In 1973 in Washington D.C. she helped found the *Religious Coalition for Abortion Rights*.


King's attention was also focused on sex discrimination in the workplace. She, along with others, founded *Focus on Equal Employment for Women* in January 1970. She was instrumental in filing a complaint against the University of Michigan that spoke to sex discrimination in hiring, promotion, pay, nepotism, and benefits in terms of women students and staff. As a result, in 1971 the salaries of 100 U of M women faculty were doubled. In 1974 King drafted a sex discrimination complaint against Houghton-Mifflin textbooks used in the elementary schools in Kalamazoo. Almost immediately the publisher revised the textbooks.

From 1974 to present King has handled dozens of cases and complaints under Title IX. These were usually in the area of athletics with regard to discrimination against women and girls. In 1980 the clout of U of M's new sexual harassment policy was substantially increased, when King represented two students, who brought sexual harassment complaints against U of M faculty members.

King has also served as the co-chairperson of the research committee of the federal Glass Ceiling Commission, on the steering committee of the annual National Women and the Law Conference, and as president of the Women's Law Fund of Cleveland, Ohio. King was inducted into the Michigan Women's Hall of Fame in 2006 and was named a Champion of Justice by the State Bar of Michigan. Recently the Women's Center of Southeastern Michigan became the Jean Ledwith King Women's Center of Southeastern Michigan. King has been an active member of the Ann Arbor branch for almost 50 years, as well as The League of Women Voters and NOW. King's intelligence, persistence, and unyielding voice, as she fought for equity for women and girls, illustrate the purpose of this award.

Financial Statement

- 1. AAUW of Michigan financial records were reviewed on July 17, 2013 and were found to be in good order.
- 2. Due to the time needed for publication of the annual report book, both the financial statement and budget summary reports are through March 31, 2014.

Membership

- 1. As of February 1, 2014 there are 37 active Michigan branches with a total of 2,618 members.
- The number of voting delegates for each branch at the AAUW of Michigan State Convention is based on the membership reported to the Finance Vice President by February 1st of the current year.
- 3. As of March 16, 2014, membership dues may be submitted for 2014-2015. Association dues remain unchanged from 2013-14. AAUW MI dues increased by \$2.00 as voted on at the 2013 Annual Meeting and are as shown below:

Dual members pay their state dues to their primary branch only if both branches are in Michigan. E-SAF members pay no dues but are not counted in Michigan branch membership totals

When reporting your membership, please remember to include your honorary members to both AAUW and AAUW of Michigan. Many of our discrepancies appear to be caused by under-reporting of these valuable members. It is also important to report any relocations or deaths of these members.

Eleven Michigan branches participated in the Membership Payment Program (MPP) during 2013-14 for payment of national, state and local dues. The MPP has successfully simplified dues payments at the payment end into an online tool that is simple, convenient and with immediately available information on membership status. For the 2014 – 2015 fiscal year AAUW has altered the process. You may continue sending in the total dues owed by each member or you may only send in the State (\$12.00) and National (\$49.00) portion of the members' dues. This will cut out the necessity of AAUW returning the local dues. Of course, they will deposit the local dues of those members who renew online. AAUW has the ability to send invoices to your members by email to remind them of dues processing.

Information about all aspects of AAUW dues remittance options may be readily accessed through the AAUW website at **www.aauw.org.** Branch finance officers are encouraged to use the comprehensive finance toolkit which provides answers to many questions branch treasurers may have. Information especially related to the MPP may be obtained through the Member Center by accessing the Membership Payment Program link.

Finance officers who prefer paper-based member management may continue to do so with the traditional dues collection process using the Branch Dues Report (BDR) and Additional Dues Report (ADR) forms. Current forms for 2014-15 will be sent electronically to branch finance officers with copies to branch presidents and membership vice presidents on or shortly after May 1, 2014. In all cases for dues submission information to AAUW of Michigan, please continue to use the summary cover sheet sent to all branches and include copies of your BDR and ADR forms.

It has been my great pleasure to have served as Finance VP for AAUW of Michigan for the past year. I enjoy speaking and communicating with branch counterparts. I will continue as Finance VP for the 2014 - 2015 program year. I hope that some of you will consider serving in this position. It is an excellent way to join the state board. This convention marks two historic events: the organizational founding of the Detroit Branch in 1889 and of AAUW of Michigan held in Detroit 1922.

Longevity...The lifespan of an individual or an organization is oftentimes lauded as a measure of success. Time, however, simply marks a starting point; the space traveled towards a destination or goal. It is the people, experiences, impact on lives, relationships, obstacles overcome, individually and collectively, the constant forward motion that determine true success. Indeed, it is the journey and how well it is traveled that reflects how far you've come.

For 125 years and 92 years respectively, our organizations have been "providing educational funding, advocating for laws that are fair, protecting those facing discrimination, researching issues important to women and families, teaching girls to be leaders," a well-travel journey with miles of road yet to cover.

Our achievements during 2013-2014 include: an increase in membership, hosting wellplanned and well-attended state conferences and conventions; establishing regular conference calls with branch leaders, branch counterparts and our college and university partner representatives. And, during that time continued my active role as Detroit Branch Co-President.

It has deepened my appreciation, empathy, and understanding for those who take on leadership. My gratitude to those who have challenged, encouraged, mentored, and supported me during my term. 

AAUW of Michigan Anti-Voucher Resolution 2014

- Whereas, AAUW believes that quality public education is the foundation of a democratic society;
- Whereas, Public education defines and advances the nation's commitment to the basic principles of equity, fairness and opportunity for all;
- Whereas, A system of vouchers has the potential of discriminating among students on the basis of religion, gender, disability, language proficiency, income and location, thereby segregating children;
- Whereas, Private and religious schools are not required to observe federal nondiscrimination laws, such as Title IX, that apply to state public schools receiving federal funds;
- Whereas, Private and religious school voucher programs weaken the public school system by diverting already scarce funds away from public education;
- Whereas, AAUW of Michigan supports adequate and equitable funding for quality education for all children;
- Whereas, AAUW of Michigan supports the use of public funds for public schools only;
- Whereas, Article VIII, Section 2 of the Constitution of the State of Michigan states: No public monies shall be appropriated or paid or any public credit utilized to aid or maintain any private, denominational or other nonpublic, preelementary, elementary, or secondary school. No payment, credit, tax benefit or tuition voucher of public monies shall be provided, directly or indirectly, to support the attendance of any student at any such nonpublic school; now, therefore, be it
- **Resolved**, That AAUW of Michigan will join with the appropriate efforts and/or actions of individuals and/or groups that oppose the implementation of the use of vouchers, tax credits, scholarships, or any other efforts to provide taxpayer dollars to parents of private school students, to charter schools that do not adhere to the same civil rights and accountability standards as required of other public schools, or to home-schooled children for the purposes of financing an alternative to public education; and,
- *Resolved*, That the appropriate efforts and/or activities are to be determined by the AAUW of Michigan State Board of Directors.

BYLAWS & POLICIES DIRECTOR, 2013-2014 ANNUAL REPORT

Revisions to the National AAUW bylaws were adopted at the June 9-12, 2013 Convention and Biennial Meeting. States and branches were notified and expected to review and incorporate these changes in their respective bylaws by December 2013. A streamlined explanation of the mandatory changes to bylaws, as required of AAUW-affiliated entities by the IRS and Washington, D.C. code, is posted on the AAUW website. The first link on the web page takes you to the revised Mandatory Conformance memo, and three additional links provide information regarding recommended best practices, past mandatory conformance changes and the 2013 bylaw change that does not require branch or state action.

The AAUW of Michigan Board of Directors incorporated the mandatory bylaws revisions in July 20-21, 2013 and adopted another recommended revision proposed by the Bylaws and Policies Committee in winter 2013, which will be voted on by the delegates at the state AAUW of MI Annual Convention in Detroit on May 17, 2014. The proposed bylaw revision, which was published in the spring 2014 issue of **AAUW of Michigan** addresses the need for electronic voting by any means. This will facilitate greater efficiency in conducting business and fuller participation of board members. It may also help to encourage more branch members to consider serving on the state board of directors. If the state or the branch wishes to use electronic voting on issues as well as for ballot election, its bylaws must so state. The proposed amended bylaw, intent, rationale and current amendment are printed on the following pages. Under the proposed amended bylaw, proposed changes are **boldfaced and underscored**; proposed deletions are **boldfaced and struck out.**

Sixteen (16) of the state's thirty seven (37) active branches have filed amended branch bylaws that are in compliance with the 2013 mandatory national AAUW directives. Two (2) of the sixteen (16) branches who have sent amended branch bylaws for the state committee to review still need to return final copies of bylaws for state and national filing. The process of bylaws revisions has been slow. It is the responsibility of AAUW state and branch presidents to ensure that all mandatory changes are made to their current state/branch bylaws. Branches should send their proposed changes to the state bylaws director who will forward to the bylaws committee for review and approval *prior* to submitting electronically to AAUW. Updated branch and state bylaws are sent to AAUW via connect@aauw.org to be maintained at national headquarters as required by the IRS by May 15, 2014.

The AAUW Affiliate Agreement is the legal contract between AAUW and each of its affiliated entities. Required and approved by the IRS, this document also meets the requirements of the District of Columbia Code-D.C. Nonprofit Corporation Act. These requirements stipulate that documents of the Affiliate(s) must remain consistent in all material aspects with the AAUW Bylaws or, in other words, must be in conformance and that AAUW keep a current copy of all AAUW-affiliated entities' bylaws.

Direct implications for branches out of bylaws compliance with the 2009 and 2013 mandatory changes in national and state bylaws are reflected clearly in the language in Article III. Use of Name, Section 2. Proper Use of Name and Logo. The name and logo of AAUW may be used only by individuals and groups acting in a lawful and ethical manner, consistent with AAUW policies and procedures. Branches and states that are delinquent in filing required tax, corporate, and/or bylaws documents with AAUW and/or the IRS are prohibited from public use of the name and logo. Further sanctions for misuse of name, including loss of AAUW affiliation, may be imposed by the AAUW Board of Directors, especially in regard to any statement or action that misrepresents or jeopardizes the tax status of AAUW.

No branches submitted proposals for state bylaws amendments by the December 1, 2013 deadline.

For the proposed amendment, the intent, rationale, current bylaw, proposed amendment and the proposed amended bylaw are below. Under the proposed amended bylaw, proposed additions are **boldfaced and underscored**; proposed deletions are **boldfaced and struck out**. The intent of including electronic meeting participation is to allow for board members that may be unable to physically attend a meeting site to participate and vote on issues necessary for carrying on the state business in an efficient and more cost effective manner. The rationale is that we need a bylaw amendment to authorize electronic meetings of the board according to Robert's Rules of Order Newly Revised (RONR) 11th edition, page 97, Section II 9-14:

Except as authorized *in the bylaws,* the business of an organization or board can be validly transacted only at a regular or properly called *meeting--*that is defined on pages 81-82, a single official gathering in one room or area--of the assembly of its members at which a quorum is present.

In addition, **RONR** defines an electronic meeting as one where some or all of the members communicate electronically (by any means). That means that even if only one member attended a meeting by electronic means (e.g., telephone, Skype, Adobe Connect, video conferencing, etc.), the meeting is classified as an electronic meeting.

- **b. Regular Meetings** Regular meetings of the Board of Directors shall be held at least twice a year at the call of the president at such time and place as she/he shall designate.
- **c. Special Meetings** Special meetings of the Board of Directors shall be called at any time by the president or upon written request of three (3) members of the board provided that at least three (3) days' notice of such meetings and its agenda shall have been given to the members of the board.
- **<u>d.</u> Quorum** A quorum of the Board of Directors shall be the majority of the members of the board, two of whom shall be elected officers. Co-officers shall be considered as one voting member of the board.

The AAUW Federal Policy Agenda for 2013-2014 builds on more than a century of advocacy by AAUW members at the local, state, national and international levels. During the past year AAUW of Michigan has been actively engaged in advocacy in three of the AAUW issue-oriented categories identified as AAUW action priorities. The categories are: **CIVIL RIGHTS, ECONOMIC SECURITY, EDUCATION** and a priority for AAUW of Michigan because of the AAUW Public Policy Impact Grant awarded by the national AAUW, **HUMAN TRAFFICKING**.

CIVIL RIGHTS

During 2013 the Michigan legislature put into law some of the most restrictive reproductive rights bills in the country. AAUW of Michigan members throughout the state were encouraged to contact their legislators and advocate for the AAUW position in support of choice in the determination of one's reproductive life.

ECONOMIC SECURITY

Tuesday, April 8, 2014 is National Equal Pay Day. It is the day that symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year. Tuesday is the day of the week on which women's wages catch up to men's wages from the previous week. This year, AAUW of Michigan, along with Michigan NOW, and LWV of MI has taken the lead in organizing the Equal Pay Day (EPD) event at the State Capitol in Lansing.

However, this year, because legislators in Lansing are taking a three-week recess, both chambers will be back in session on April 29. A decision was made by the Equal pay Day Coalition members to hold the **Michigan EPD on Tuesday, April 29.** There will be a Legislative briefing in the morning, an EPD event at the Capitol Rotunda at noon, and an opportunity for lobbying legislators in the afternoon.

A coalition of groups and organizations in support of pay equity legislation organized the events for April 29. Legislators were invited to attend the event and to speak about the issue of the gender pay gap in women's wages as compared to men's wages for full-time, year-round employment.

In addition to AAUW of Michigan the coalition includes, American Civil Liberties Union of Michigan (ACLU); AFT Michigan; Business and Professional Women, Michigan Federation; Coalition of Labor Union Women, Metro-Detroit Chapter; PEN C.L.U.W.; League of Women Voters of Michigan; Michigan American Council on Education (ACE) Network for Women; Michigan National Organization for Women; Michigan Women's Studies Association; Michigan Women Lawyers Association; Oakland/Macomb

Michigan NOW; National Council of Jewish Women, Greater Detroit Section; Women's Center of Greater Lansing; Lansing Association For Human Rights; National Council on Women and Girls; and Zonta International, District 15.

Equal Pay Day Legislative Briefing on April 29. In 2012 and 2013, it was decided to add a new dimension to the EPD events in Lansing by providing Lobbying Training for those interested in learning more about effective interaction with legislators and/or their office staff. In 2014 the title for the workshop was changed to a Legislative Briefing. A publicity flyer, including a registration form, was created and distributed to all coalition organizations. A small fee was requested on the registration form to help defray expenses for refreshments for the Briefing, as well as printed materials for participants' folders. The AAUW of Michigan Finance Vice President serves as administrator for the funds associated with the Equal Pay Day events. The AAUW of Michigan Funds Director, Mickey Edell, served as moderator for planning committee conference calls and as communications facilitator among the coalition organizations.

The Legislative Briefing will have two main presenters: one from the Office of Federal Contract Compliance Programs (OFCCP) in Detroit, and the other from the ACLU of Michigan.

In addition to the Legislative Briefing, an EPD event was planned to take place in the Rotunda at the State Capitol in Lansing from noon to 1:00 p.m. on April 29. The public and the press were invited. Everyone was encouraged to wear red, as a symbol of how far women and minorities are "in the red" with their pay.

AAUW of Michigan State President, Janet Watkins, was the moderator for the event. AAUW is regarded as a lead organization in the attempt to pass pay equity legislation in Michigan because of the research reports produced by the national AAUW. In 2007 the report was **Behind the Pay Gap**. In 2013 and again in 2014, updated copies of **The Simple Truth About the Gender Pay Gap** were distributed to all Michigan legislators on April 29. Mickey Edell, AAUW Funds Director, and Sharon Belobraidich, Branch Liaison Director, provided copies of the publication, along with **Equal Pay Day cookies**, (with a segment removed), symbolizing the wage portion absent from women's earnings as compared to men's.

Since not everyone is able to attend the Equal Pay Day event in Lansing, a **Virtual Lobby Month** (April 1 – 30) was made available by accessing the AAUW of Michigan website (www.aauwmi.org) to allow members from all parts of the state to participate in the event by contacting their legislators. By following the prompts, members can send a message to House Representatives and Senators letting them know the pay equity bills introduced in the House and Senate in April 2013 need to be a priority for legislators. The impact of pay inequity is felt by all of their constituents, women and men alike, particularly during difficult economic times. The message to legislators is that it is time for the wage disparities to end.

Janet Watkins, AAUW of Michigan President, worked with national AAUW Public Policy staff in DC to create the materials used in the Virtual Lobby effort via Salsa.

EDUCATION

For many years AAUW of Michigan has belonged to several education coalitions, including Council About Parochiaid (CAP), formed in the 1970s; Michigan For Public Education (MFPE), organized in 1994; and has been associated with the Michigan Gender Equity Team (M GET) for the past 16 years. Of particular concern to AAUW of Michigan members are issues related to Charter Schools, School Vouchers, School Funding, Single-Sex Education and Science, Technology, Engineering and Mathematics (STEM) Education

HUMAN TRAFFICKING

Human Trafficking was chosen as one of two priority issues (the other being Pay Equity) in the application for the 2013 Impact Grant awarded to AAUW of Michigan. Human Trafficking is considered to be modern day slavery, and is the third largest criminal enterprise in the world, accounting for 32 billion dollars in monetary transactions.

The Michigan Human Trafficking Task Force (MHTTF) was formed in 2012 to address the issue and to recommend badly needed legislation on the subject. State President, Janet Watkins, and Membership V.P. Dr. Penny Larsen joined the Task Force (TF) as representatives of AAUW of Michigan. The state board voted to support the efforts of the RF by contributing some of the Impact Grant funds to the work of the TF, making AAUW of MI a coalition member.

Four bills, of the 26 bills that have been introduced in Lansing, are supported by AAUW of MI. They are:

Safe Harbor Bill – The MHTTF endorses the Safe Harbor Bill but believes it should not have 17 year olds under the control of Protective Services.

HB 5158 – This bill would create the Human Trafficking Commission Act. It would be an autonomous entity within the Department of Attorney General. All business performed by the Commission would have to be conducted at public meetings in compliance with the Open Meetings Act and writings prepared,

owned, used, in the possession of, or retained by the Commission in the performance of an official function would be subject to the Freedom of Information Act (FOIA).

SB 584 – This bill, introduced by Senator Judy Emmons, would eliminate statute of limitations for trafficking offenses and the commercial exploitation of children. It would be called the "Therese Flores Act."

SB 588 – Senate Order affirmative defense that essentially allows a human trafficking victim's record to be expunged.

Branches that held programs or events on either of the two priority issues of Pay Equity or Human Trafficking were encouraged to apply for mini-grants from AAUW of Michigan to help defray expenses associated with organizing the programs or events on those subjects. A number of branches applied for the mini-grants and were awarded funds from the Public Policy Impact Grant budget line.

Last year, when I presented a Diversity and Inclusion piece at Conference, I received a 56% overall rating. I am proud of all of us for such an outcome. I was very pleasantly surprised. Disagreement, conflict is healthy. Many of us turn away from conflict, from responsibility. It seems/appears to me that we run from taking responsibility of, for, and to our humanity. This is a major factor in why we do not have inclusion.

As humans we each must realize the right of all living things to live, simply. We must each begin to actively engage in inclusive thinking and living behavior, for the good of all. The question I ask myself is: "How much of anything and everything do any of us need?" I live my life knowing that social justice in the culture of the world is mandatory if we are to continue to live. And, it is at the root of inclusion. As I stated last year, and will do so again, "diversity exists, inclusion does not. And, again, inclusion is about *social justice*, as choice.

I have not been as present as I had hoped this past year. Therefore, as an assist, I recommend reading books such as "Bury my Heart at Wounded Knee"; "Before the Mayflower" by LeRone Bennett Jr.; the work of Howard Zen and John Henrik Clarke. 

Michigan For Public Education (formerly the Michigan Public Education Task Force) is a nonprofit, nonpartisan organization comprised of individuals and organizations advocating for and promoting public schools.

We vow to:

- Uphold Article 8, Section 2 of the Michigan Constitution which states: "The legislature shall maintain and support a system of free public and elementary schools as defined by law. Every school district shall provide for the education of its pupils without discrimination as to religion, creed, race, color or national origin."
- Preserve the First Amendment separation of religion and state in the public schools.
- Defend public education when it is wrongly attacked. Present a truthful understanding of public schools through the use of relevant and accurate data.

The membership consists of organizations and individuals who support the purpose of MFPE. Each member organization shall appoint a representative to attend meetings and report activities to its membership.

MFPE meets quarterly on the first Friday of the month from 1:00 p.m. to 3:00 p.m. Meetings alternate between the National Council of Jewish Women (NCJW) Greater Detroit Section in Southfield, the Michigan Education Association (MEA) Building in E. Lansing, Michigan and the Michigan Association of School Boards (MASB) office in Lansing, Michigan.

MFPE membership includes access to the MFPE Listserve. The MFPE Website address is www.mfpe.net.

COUNCIL ABOUT PAROCHIAID (CAP) 2013-2014 ANNUAL REPORT

The Council of Organizations and Others for Education About Parochiaid (CAP) has a website (www.capmichigan.org) where the history of the Council is described in detail. CAP became active in Michigan politics during the 1970's, and is comprised of representatives of child advocacy, civil rights and education groups supporting the constitutional guarantee of a free public education for all Michigan children. Because AAUW supports public funding for public education, a close tie between AAUW and CAP has existed since the Council was first organized.

At each quarterly CAP meeting, there is a Legislative Update prepared by Capitol Services and reported to the members in attendance. Following the meeting, the legislative report is posted on the CAP website for the benefit of individuals interested in separation of church and state issues in public education.

The CAP Board of Directors is made up of four elected officers and four At-Large Directors. On March 14, 2014 a new slate of officers was elected. Their two-year terms of office will begin June 1, 2014. The elected officers are: Sandra York, (Michigan PTA) President; Lois Lofton Doniver, (AFT Michigan); Vice President; Rodd Monts, (ACLU) Secretary; and Fern Ettinger, (National Council of Jewish Women, Greater Detroit Section or NCJW) Treasurer. In addition, the At-Large Directors are: Barbara Bonsignore (AAUW of Michigan); Paul Liabenow (Michigan Elementary and Middle School Principals Association or MEMSPA); Jennifer Smith (MI Assoc. of School Boards or MASB); and Wendy Zdeb-Roper (Michigan Association of Secondary School Principals or MASSP). Meetings are held quarterly, in locations that alternate between Lansing and Southfield. The officers listed above were elected to serve for the 2014-2016 term.

Because November 2014 will be the occasion for a gubernatorial election, as well as contests for a number of state seats, it is likely that CAP will conduct a Candidate Questionnaire in the fall of 2014. The polling includes candidates for Governor, House, Senate, State Board of Education and Attorney General, to ascertain each candidate's stance on funding for parochial/religious schools. The questions asked in previous election cycles were these:

1. Do you support or oppose using public funds, either directly or indirectly, for payment, credit, tax benefit, exemption or deductions, tuition voucher or subsidy, grant or loan to support the attendance of any student at a K-12 parochial/religious school?

2. Would you support or oppose amending the Michigan Constitution to permit or allow the use of public funds for payment, credit, tax benefit, exemptions or deductions, tuition voucher or subsidy, grant or loan to support the attendance of any student at a K-12 parochial/religious school?

AAUW members are urged to attend CAP meetings. If a member is interested and available to serve as the AAUW representative to the Council, contact AAUW of MI President Janet Watkins, or President-Elect Elizabeth Haynes to indicate your interest and availability. Go to the CAP website (www.capmichigan.org) for the details of date, time, and location of future meetings. The results of the Candidate Questionnaire mentioned above will also be available on the website in September, 2014.

Michigan ERAmerica, 2013-2014 AAUW Coalition Report

Michigan ERAmerica, formed in 1976, is an all-volunteer coalition of organizations and individuals in this state working to complete the ratification of the Equal Rights Amendment. Although Michigan ratified the Equal Rights Amendment in 1972, the ERA needs to be ratified by three more states before it becomes part of the Constitution,

In 2013, Michigan ERAmerica focused its efforts on securing co-signers for two identical bills that would remove the congressionally imposed deadline for ratification of the original ERA – S.J. Res. 15 and H.J. Res. 43. These bills require only a simple majority of Congress to pass.

US Senators Carl Levin and Debbie Stabenow are original co-sponsors of S.J. Res. 15. In the House, US Representatives John Conyers, John Dingell, Sander Levin are also original co-sponsors of H.J. Res. 43 when both bills were introduced on May 9, 2013.

Representative Gary Peters became a co-sponsor several weeks later. This left freshman Representative Dale Kildee of Flint as the only member of the Michigan's Democratic Congressional Caucus who had not signed.

We knew that Representative Kildee supports the Equal Rights Amendment because he co-signed H.J. Res. 56. This bill would require Congress to start-over by re-approving the ERA by two-thirds majority of both Houses and thirty-eight states would have to ratify it. This means states that originally ratified the ERA would have to re-ratify.

Representative Kildee, as all legislators, is surrounded by staff that act as gatekeepers. Our challenge was to find a way to inform him about H.J. 43 and gain his support. We made numerous attempts to no avail.

Therefore, we sought help from Michigan AAUW Public Policy Chair, Barbara Bonsignore. In turn, Barbara contacted Melissa Jackowski, National AAUW Staff member. Melissa created an E-mail message for Flint AAUW members. It was sent state-wide by Michigan AAUW president, Janet Watkins. We also, had help from Flint NOW.

Happily, this concerted effort worked and Representative Dale Kildee is now a co-signer of H.J. 43.

In addition to working for ratification of the ERA, Michigan ERAmerica, its educational arm, Michigan Coalition for Equal Rights Studies and Michigan AAUW partnered in presenting a Women's Equality Day luncheon in Livonia on August 24, 2013.

Two speakers, State Representative Rashida H. and Tlaib and Mary Pollock Legislative Vice President of the National Organization for Women of Michigan, gave us a legislative update on Women's Issues entitled, "What the Heck is Going on in Michigan?"

Plymouth-Canton AAUW member, Sharon Belobraidich wrote an original skit entitled "Meet the Steminists" – notable Michigan women active in Science, Technology, Engineering and, Math. Sharon, along with former AAUW state president Mickey Edell performed the skit.

Both presentations were well received.


