

#### CHARTING A COURSE TOWARDS EQUITY

The Port Huron branch of AAUW welcomes you! The city of Port Huron is the most easterly point in Michigan and borders 7 miles along the St Clair River. Drive anywhere in the city and you will most likely see water—the St Clair River, the Black River and, of course, Lake Huron. What a treat!

Port Huron abounds in history. The city was incorporated in 1857 as the hub for shipbuilding and the lumber trade. Prior to the Civil War Port Huron also became a terminal for the Underground Railroad. In 1859 the Edison family moved to Port Huron for employment with the new railroad. Young Thomas, age 12, then would ride the train from Port Huron to Detroit selling newspapers and candy which financed his purchases to use for his chemicals and experimental supplies. The Thomas Edison Depot now stands on that spot. In 1896 the impressive Harrington Hotel opened. In 1919 young Harry Truman and his new bride, Bess, honeymooned here. The Harrington Hotel is now on the National Registry of Historic Places. In 1902 the city secured funds from philanthropist, Andrew Carnegie, to build a municipal library where Milvil Dewey (Dewey decimal system) gave the opening address. It is here where a 16 year old Port Huron girl, Terry McMillan, was hired to shelve books at the library. This job introduced her to a world of books and imagination resulting in our well known author! This library now houses the Port Huron Museum Carnegie Center. The Port Huron Museum comprises 3 others sites: the Thomas Edison Depot Museum, the Huron Lightship and the Fort Gratiot Lighthouse (oldest lighthouse in Michigan).

Residents and tourists have year round fun! Summer brings out the boats, the freighters, small water craft and the public beaches. The Port Huron to Mackinac Sailboat Race, a well known attraction, brings thousands of people for the weekend as does the Sandfest and other boat races. The city boasts tennis courts, both indoor and outdoor, parks and picnic areas, a marina and boat launches. Winter arrives with hockey and figure skating. Scott Hamilton, well known American figure skater, 1984 Olympic Gold Medalist, appeared here at McMorran Arena early in his career.

Music and art are significant as well. So many sights to behold! View the sculpture pieces including the Night and Day fountain sculptured by Marshall Frederick in front of McMorran, the statue of Thomas Edison and the Blue Water Maiden, The International Symphony, School For Strings and Port Huron Town Hall are some of our other cultural opportunities.

Our health care needs are well met by the professional staffs of McLaren Port Huron Hospital, Karmanos Cancer Center and Lake Huron Medical Center. Our education and technical training needs are met by St Clair County Community College, Baker College and the Culinary Institute. These, along with Blue Water Transportation, are the backbone of our city!

A big thanks to our community, Port Huron AAUW, and State Board members for insuring a successful Convention. We are so happy to share our heritage with all of you and invite you to return.

#### AAUW OF MICHIGAN 94th ANNUAL MEETING & CONVENTION MINUTES

April 30, 2016 Somerset Inn, Troy, MI Theme: *Members In Action* 

AAUW of Michigan President Elizabeth Haynes called the business meeting of the AAUW of Michigan 94th Annual Convention to order at 11:05 a.m. on Saturday April 30, 2016, at Somerset Inn, Troy, MI.

AAUW of Michigan Secretary Amy Shamroe read greetings received from AAUW of Michigan past Presidents Harriet Sawyer (1983 – 1985) and Carole Wells (2000 – 2002)

AAUW of Michigan secretary called the roll of branches: 25 branches were represented.

President Haynes introduced past state presidents: Mickey Edell, Sally Doty and Janet Watkins and Meg Brown.

President Haynes introduced the head table: Secretary Amy Shamroe, Traverse City; Parliamentarian Myra Willis, CFUW Oakville; and Timekeeper Barbara Bolek, Wyandotte Downriver.

**Reports of the finance vice-president:** Finance Vice-President Karen Mars presented the financial statement and budget summary through March 31, 2016 found on pages 20 through 25. **The finance vice-president's report was filed for audit.** 

Reports of the officers were presented in the convention book on pages 26 – 36 No updates to the reports were presented.

**Resolutions.** Sally Doty presented the report of the Resolutions committee, found on page 38-39 of the convention book. She also **moved the adoption of the courtesy resolution.**

RESOLVED, That members of AAUW of Michigan gathered at the Annual Meeting salute all those named in this resolution and all who are present.

The courtesy resolution was adopted as presented.

**Bylaws.** Susan Hampton presented the report of the Bylaws Committee found on pages 40-43 of the 2016 Program Book. Susan moved that Article VI of the AAUWMI bylaws be amended by substituting new section 3.a. **By unanimous consent the proposed amendment was amended by deleting the final sentence.** "The finance vice president shall be eligible for two (2) consecutive two-year terms in the same office".

#### The motion to amend the article VI.3.a was adopted as amended.

VI.3.a.Terms of Office. Except for the president and president-elect, all board members shall be eligible to serve for two (2) two-year terms in the same office or until their successors have been elected or appointed and have assumed office. The president-elect shall be elected for a term of one (1) year and shall succeed to a two-year term as president in the following year.

**Nominations.** Susan Hampton, chair of the Nominations Committee, introduced the slate of officers for 2016-17: Janet Watkins VP Program; Sharon Dunn AAUW Funds Director, and Jan VanGasse Secretary. There were no nominations from the floor. **President Haynes declared nominations closed, and the slate was elected.**

Coalition reports were presented in the convention book on pages 62-64. There were no additions to the reports.

#### New Business.

President Haynes delivered her president's message and thanked her board for their efforts in 2015-16.

AAUW Funds Director Sharon Dunn presented Funds Awards.

Vice President of Membership Deb Kennedy presented membership awards.

AAUW Vice President of Membership and Direct Marketing Christy Jones installed the newly elected officers. President Elizabeth Haynes passed the Gavel to President-Elect Penny Larsen who will assume office as AAUWMI President on July 1, 2016.

## CONVENTION RULES ARTICLE X. MEETINGS OF AAUWMI

#### Section 1. Time, place and notification

- a. AAUWMI shall hold at least one regular meeting each year at the state convention to conduct the business of AAUWMI, including the election of officers and the receiving of reports of officers and committee chairs.
- b. The time and place shall be determined by the AAUWMI board of directors.
- c. Special meetings may be called by the president on the written request of a majority of the members of the Board of Directors.
- d. Written notice of meetings shall be sent to all members of AAUWMI at least thirty (30) days prior to the meeting. Notice shall include time, place and purpose for the meeting.
- e. All AAUWMI meetings, including meetings of the Board of Directors, shall be open and may be attended by any member.
- f. If circumstances prevent the holding of an AAUWMI meeting, the Board of Directors shall provide for the conducting of necessary business.

#### Section 2. Representation

- **a. Voting Body.** The voting body of any meeting of AAUWMI shall be composed of:
  - 1) State Representatives including the following:
    - The members of the Board of Directors, including chairs of all standing committees, excluding the parliamentarian and State Services Manager.
    - b) Past presidents of AAUWMI.
    - c) The following convention committee chairs: Nominating, Resolutions, Credentials, Tellers, and Pages.
    - d) Representatives of College/University Members.
    - e) AAUWMI members serving as national officers or on national AAUW committees.
  - 2) **Affiliate Delegates** including the following:
    - a) The president of the affiliate or her/his designated alternate.
    - b) One delegate for each 25 members of each affiliate or major fraction thereof. Representation shall be based on the records of AAUWMI finance vise president as of February 1. Each affiliate shall be entitled to at least one such delegate.
  - 3) **Other Delegates**. One delegate appointed by the state president for each 25 paid-up AAUWMI members who are not represented in the affiliate delegations.
- b. **Voting.** A member of the voting body shall cast no more than one vote.
- c. **Quorum.** A quorum of a meeting of AAUWMI shall be 25% of members eligible to serve as delegates and attending, provided one-third of the affiliates are represented. This quorum shall include two elected officers of AAUWMI.

## CONVENTION RULES cont. ARTICLE XVII. RESOLUTIONS

#### Section 2. Resolutions

- a. Resolutions from branches or individuals shall be submitted in writing to the chair of the resolutions committee at least sixty (60) days prior to the annual meeting, the specific date to be set by the state presidents. The chair shall report to the members of the committee all resolutions submitted.
- b. The resolutions committee shall be empowered to reject any resolutions which is in conflict with AAUW or AAUWMI bylaws, combine and/or consolidate resolutions of similar import, make editorial changes, make suggestions for implementation, report to the AAUWMI board the committee's approval or rejection of the proposed resolution(s), and initiate and propose courtesy resolutions.
- c. The resolutions committee shall report their recommended resolutions to the board for its approval. The board shall report the recommended resolutions to the branches at least forty-five (45) days prior to the annual meeting.
- d. The resolutions shall be adopted by a majority vote of eligible voters present at an annual AAUWMI meeting where a quorum is present.
- e. The resolutions committee shall review an adopted resolution every five (5) years on its anniversary date to determine if it is "current" or "historic" and report its status to the membership at the annual AAUWMI meeting.

**Section 3. Resolutions from the Floor.** Resolutions may be proposed from the floor, provided each resolution is permitted by a two-thirds vote of the delegates attending a meeting in which a quorum of eligible voters is present; a three-fourths vote shall be necessary to adopt a resolution from the floor.

#### PRIVILEGES OF THE FLOOR:

- A. The convention shall be open to all members and visitors. Only accredited delegates shall be entitled to offer motions and resolutions from the floor, debate, and vote.
- B. All accredited delegates shall be seated in the voting section.
- C. Any accredited delegate desirous of speaking shall first rise, address the chair, state her/his name and branch if applicable, and obtain recognition from the presiding officer.
- D. No accredited delegate shall be allowed the privilege of the floor a second time, to speak on the same question, as long as any accredited delegate who has not spoken to that question wishes to speak. This rule does not apply to the chair of a committee making a report, or to the speaker presenting a subject. These persons shall have three minutes for closing debate without the consent of the convention.
- E. No one may speak longer than three minutes at a time without the unanimous consent of the convention. A signal shall be given at one minute and at thirty seconds before the time limit of each speaker has been reached. The ruling of the timekeeper shall be strictly adhered to.
- F. During debate an effort will be made to alternate between supporting and opposing arguments.
- G. Debate will be limited to thirty (30) minutes on those items requiring a vote.

#### **CONVENTION RULES cont.**

#### **MOTIONS:**

All motions shall be submitted in writing on motion forms, available from the pages. One copy shall be given to the secretary and one copy shall be given, to the presiding officer. Each shall be signed by the maker of the motion, stating his/her branch if applicable and delegate status.

#### **CHANGES IN DELEGATE/CREDENTIAL STATUS:**

- A. All changes in credentials shall be made at the Credential Desk.
- B. An alternate assuming delegate status shall wear her/his own convention badge in addition to the delegate's badge. In this case, the alternate shall be seated in the voting section and shall be allowed to present motions, debate, and vote.

As of February 1, 2017, there are 33 active Michigan branches with a total of 2,357 members. The number of voting delegates for each branch at the AAUW of Michigan State Convention is based on the membership reported to the Finance Vice President by February 1<sup>st</sup> of the current year.

Membership dues may now be submitted for 2017-2018. AAUW dues and AAUW MI dues remain unchanged from 2016-17. A Member of Branch (MOB) pays \$49 association dues (\$46 tax deductible), \$12 state dues and branch dues. A Paid Life Member (MBL) pays only state and branch dues. An Honorary Member (MBHL) pays no dues. Dual members pay state dues only if their primary branch is out of state. Student Affiliate Members (SAF) pay association dues of \$17 (\$16 tax deductible) and state dues of \$2.

Whether you are using the MPP (Membership Payment Program) or not, please,

remember to include your **honorary members.** Many of our discrepancies appear to be caused by under-reporting of these valuable members. It is also important to report any relocations or deaths for these members.

This year AAUW MI is instituting a more collaborative relationship between the finance and membership vice presidents. Dues will be submitted to the membership vice president designated as the dues treasurer. This will enable the membership team to have more timely information about your branch. This will allow them to investigate branch successes to share with others and to present possible strategies to those branches that are having a more difficult time.

Questions about dues and other financial concerns will still be answered by the finance vice president.

As you can see by examining the branch summary report you will see that we have one less branch this year and, although we have 177 new members, our total membership is down by 51 members. It is a concern that we have fewer members and more honorary members, which results in less revenue to carry out the mission. We all need to be thinking of innovative ways to increase our resources. Your donations to AAUW MI Funds are greatly needed and appreciated – see the Budget and Financial reports.

The tools available to you on the AAUW website (aauw.org) as finance people and as members are invaluable in helping you be successful in your role.

I know that we all are wishing Karen Mars a successful recovery and thank her for her service as Finance Vice President for most of these two years.

#### **BYLAWS & POLICIES 2016-2017 ANNUAL REPORT**

Each biennium AAUW reviews and amends its national bylaws to ensure they comply with federal and Washington, D.C., statutes; reflect AAUW's current operations; serve AAUW's current needs; and protect AAUW's tax-exempt status, the IRS group exemption for AAUW affiliates, and AAUW's name, logo and ultimately AAUW's power to advocate for public policy that advances equity for women and girls. The AAUW Affiliate Agreement (the IRS-approved contract between AAUW and all affiliates, stipulates that affiliates "must conform to AAUW bylaws in all material respects." This means that ALL affiliates must re-write their bylaws to incorporate all mandatory (blue text) changes for Articles I-VII. Articles VIII and after address all affiliate-specific bylaws approved by the affiliate membership and in compliance with the state bylaws. The IRS requires that the name of the Affiliate organization be preceded with the "American Association of University Women (AAUW)." The membership voted on bylaws changes at the June 18-21, 2015 Convention in San Diego, California and will do so again in June 2017 in Washington D.C. Following many discussions about and trials with the "Model State" and "Model Branch" bylaws, AAUW's lawyers decided only one "Affiliate Bylaws Model" would be used. Key changes are these: All organizations affiliated with AAUW that support its mission shall be known as "Affiliates." The term "branch" may not be substituted for "Affiliate." AAUW recognizes two types of members: "Individual Members" and "College/University Members." The AAUW Governance Committee, the AAUWMI President and Bylaws Director sent letters to all Branch Presidents and Bylaws Chairs in mid-October 2016 when final edits were made in the "Affiliate Bylaws Model, and again in January 2017, with a reminder of the January 31, 2017 deadline for submitting bylaws. They directed branches to download the new Affiliate Bylaws Model, along with suggested guidelines about how to use the Model Affiliate Bylaws, to start the process of bylaws restatement. The model bylaws will simplify the integration of the 2015 Mandatory Conformance Memo and help integrate all future memos into affiliates' bylaws by providing a uniform framework. Mandatory revisions do not need a vote of the Affiliate membership. All previous mandatory bylaw revisions from 2011 and 2013, found on the AAUW website, must also be included in state and branch bylaws unless those revisions were changed in the 2015 amendments. Mandatory sections highlighted in blue must be included exactly as written, as well as indicated section headings and numbering. The nonmandatory provisions in plain black text are offered as guidelines based on generally accepted principles for inclusion in non-profit bylaws (which must reflect the requirements of the state statues). Affiliates may also insert additional bylaw provisions. starting with Article VIII, relevant to their own organizations, provided those provisions are voted on by the affiliate's membership following required process and that they comply with AAUW policies, federal IRS and state laws and AAUW of Michigan bylaws. Terms like "administrative officer" and "finance officer" may be replaced with comparable titles such as "president," "chair," or "treasurer."

#### Cont. BYLAWS & POLICIES 2016-2017 ANNUAL REPORT

Following review, approval and filing by the AAUWMI Bylaws Director, affiliate presidents or bylaws chairs were directed to electronically submit their affiliate restated bylaws to AAUW by January 31, 2017 at: <a href="mailto:compliance@AAUW.org">compliance@AAUW.org</a> to be maintained at the national headquarters as required by the IRS. AAUW sent an email confirmation of receipt or requested edits be made if needed.

Besides the AAUWMI, thirty (30) of thirty-three (33) Michigan AAUW Affiliates have submitted their new and approved AAUW Affiliate bylaws. Three Affiliates have requested an extension to complete theirs. Hopefully by the time of the June 2-3, 2017 state annual meeting and convention, all Michigan affiliates will be in bylaws compliance.

In addition to restating the AAUWMI bylaws, reviewing and filing (digital and hard copies) all Michigan AAUW Affiliate bylaws for state and national, the Bylaws and Policies Director updated the AAUWMI Policies that guide board operation.

The Bylaws and Policies Committee provides invaluable service to the Director by reviewing proposed amendments to bylaws and policies and reviewing branch bylaws for compliance. Thank you to this fine committee!



- c. Special meetings may be called by the president on written request of a majority of the members of the board of directors.

- e. All AAUWMI meetings, including meetings of the board of directors, shall be open and may be attended by any member.
- f. If circumstances prevent holding

#### **PUBLIC POLICY 2016-2017 ANNUAL REPORT**

The beginning of September Public Policy began the shift to the GOTV effort in this big election year. Many of the Branches have reported their candidate and issues forums on the National website, at The Advocacy Report Form.

The September Virtual Lobby Corps Conference call was on September 12th. We discussed Voter Ed. activities of the respective Branches, encouraging them to post the on the National site. We had hoped to meet in Lansing on September 20<sup>th</sup>. This date did not work out, due to lack of legislative agendas, and the election. I would like to have more participation of the members, and wrote to absentee members regarding their lack of participation after the call. Two members responded that they would like to stay on the Corps, appreciating the legislative updates and information. Our next conference call has been moved up to December 5th due to the election. We are going to ask Mary to stay apprised of the activities of the lame duck session and be present during this time period of legislative activity.

On September 17<sup>th</sup> Mary Pollock and I presented at the opening meeting of the Escanaba, Marquette and Iron Mountain Branches about Public Policy interests, policy and how they relate to the legislative agenda. GOTV was discussed and some of the conflicts presented this election year between voting and political issues. The public is often confused between the two. AAUW needs to help educate the public next election cycle on how voting and politics have become intermingled. Branch members discussed their voting forums in the coming weeks before the election. As usual I was very impressed by the interest in public policy and coordinated activities of the Upper Peninsula Branches.

On Oct. 3 rd. I attended the Voter Registration event at UM Dearborn, hosted by N'Kenge Gonzalez. AAUW and the League of Women Voters presented our materials and instructions for registering to vote. The Power Point presented by N'Kenge was very informative about voting, getting out the vote and making sure you show up to vote. We talked to many students and were very pleased to find out that most are registered to vote. It was a very productive and informative GOTV activity.

I participated on the Conference Call with Lee Savage and a few of the new members of the Student Advisory Board. We discussed the Leadership Conference and their roles. Getting students to be available for these calls is difficult with their busy lives. Participation at most conference calls is problematic. This is true for the Lobby Corps calls as well.

<u>ERA</u> Shout Out: At a Gloria Steinem event Mary reported that over 600 people at \$35 + a pop attended. Mary sent up questions about ERA and the moderator kindly picked it over about 5 dozen others. Steinem mentioned that she was scheduled to have a meeting in the coming week about new wording – adding race to the current language. Keep your ears to the ground on what that may bring. She is part of that ERA Coalition out of NY City with Jessica Neuwirth. She did not mention the Coalition in her answer. She did mention the two strategies. This is encouraging news about the ERA. As of

March 2017 we have only two states left to ratify The ERA, the state of Nevada ratified this winter. Michigan continues to push AAUW national to be more aggressive in supporting the Three/Now Two State Strategy for ratification.

Mickey Edell, Mary Pollock the Virtual Lobby Corps have been working on the Equal Pay Day committee. We are promoting more contact with the Legislators at the April 25th event. This effort was successful last year and I feel it may make more people attend. The new Virtual Lobby Corps will be present and will do some serious lobbying for Equal Pay.

Last fall was all about GOTV. I feel that this effort has been very successful, thanks to the help and support of National AAUW and our local grass roots efforts. I think my biggest take away last fall is that Getting Out the Vote for many means a partisan support of a particular candidate. This obviously reflects the need for more voter education. I plan to press National on this concern. This has been an issue this election cycle for other state AAUW Branches.

I attended a Planned Parenthood event in Lansing with the Michigan President and many legislators. It was an aggressive attempt to prevent defunding of this organization by our State Legislators. It was a proactive session and felt very productive.

#### AAUW of MICHIGAN VIRTUAL LOBBY CORPS 2016-2017 ANNUAL REPORT

AAUW of Michigan has a Virtual Lobby Corps. With the help of Elizabeth Holden at AAUW Washington we organized and put together our own Lobby Corps. We have been working together on the issues that are important to all of us: pay equity, education, reproductive rights, getting the Equal Rights Amendment ratified, and getting out the Getting Out the Vote for the past fall presidential election. With Mary Pollock's expertise on the legislative process, she will be able to keep us current in Lansing and where we need to put our best efforts. We need a group in Lansing or close to it, to help with the Legislative issues that need our input. We hope to do this in the coming year.

Mary Pollock and I have had a conference call once a month with our VLC members. We discuss legislative bills, Action Alerts on the AAUW of Michigan website in order to blast emails to legislators every day at the same time, track legislation, call legislators with specific talking points, thank them for their attention to our requests, and when needed send out Salsa alerts. We will write letters to editors for local and national papers and use social media to inform AAUW Branches and members what we are working on and how to contact their legislators.

An addition to our State Lobby Corps will be our newly formed Student Advisory Council or SAC. We are bringing our college students into the State AAUW Public Policy team. . Hopefully this will be the beginning of more contact with college students, where voices can be heard. I am hoping to enlist them to keep campus safety for all students one of their main priorities.

One of the keys to understanding this action team is to let members know that lobbying is something everyone can do and already does: with parents, spouses, siblings, partners, kids, teachers, community leaders and neighbors. Explaining our cause and its importance is something we do every day, and doing that with state representatives either in person, by phone or electronically, is basically the same thing.

We are focusing on bills or resolutions when lobbying a legislator, with specific issues. We are becoming more familiar with AAUW's policy priorities, so we can recognize issues that are important to us. The National website has position papers which are publicly available on the website will be able to provide more assistance, as we begin this lobbying effort.

Another great resource to use will be the Citizen's Guide to State Government. This guide should help the Lobby Corps to understand the legislative structure and process, then organize with our efforts to effectively demand representation. This specific information will help us to get in touch with the Right People at the RIGHT TIME.



Biennial priorities for national action are chosen according to the criteria of viability, critical need, strong member support, and potential for distinctive AAUW contribution or leadership. No order of importance is implied. The AAUW Public Policy Program is the basis for all AAUW of Michigan activities. The program can be accessed on the AAUW website (<a href="https://www.aauw.org">www.aauw.org</a>), as well as AAUW Position Papers on public policy issues.

## To support a strong system of public education that promotes gender fairness, equity, and diversity, AAUW advocates

- Adequate and equitable funding for quality public education for all students
- Opposition to the use of public funds for nonpublic elementary and secondary education and to charter schools that do not adhere to the same civil rights and accountability standards as required of other public schools
- Protection of programs that meet the needs of girls and women in elementary, secondary, and postsecondary education, including strong promotion of STEM education and comprehensive sex education
- Vigorous enforcement of Title IX and all other civil rights laws pertaining to education
- Increased support for and access to affordable higher education for women and disadvantaged populations
- Increased support for programs that break through barriers for women and girls in science, technology, engineering, and math (STEM) fields

#### To achieve economic self-sufficiency for all women, AAUW advocates

#### **GOVERNMENT RELATIONS ANNUAL REPORT**

In August 2015, the AAUW of Michigan Board of Directors authorized a contractual relationship with me to provide state government relations services.

AAUW's 2015 - 2017 Public Policy Program adopted at the June 2015 AAUW national conference guides our positions on state public policy issues. Briefly, the Biennial Action Priorities are:

- To support a strong system of public education that promotes gender fairness, equity, and diversity;
- To achieve **economic self-sufficiency** for all women;
- To guarantee equality, individual rights, and social justice for a diverse society.

The 98<sup>th</sup> Legislature ended December 31, 2016 with 563 bills signed into law and 5 vetoes out of 2113 bills introduced in the House and 1167 bills in the Senate.

On behalf of the AAUW of Michigan I followed several hundred bills relating to our Public Policy Program with an emphasis on our Biennial Action Priorities. I provide written reports to the Executive Board which are available on our Web site and provide updates to the Lobby Corps through monthly conference calls. I post frequently of our Facebook page. In the last year I have given presentations at the Escanaba, South Haven, and Northville-Novi branches.

#### **EDUCATION EQUITY**

<u>Campus Sexual Assault</u> – First Lady Sue Snyder sponsored her second conference about Campus Sexual Assault at the University of Michigan campus on September 30, 2016, which I attended.

<u>Public funding of private education</u> – There was a provision in the 2016-17 education budget act that would reimburse private schools for certain expenses related to meeting state mandates such as safety codes. Subsequently several education organizations challenged the funding in court. The plaintiffs have been made aware of our interest and support of the lawsuit.

<u>Detroit Public Schools</u> - The AAUW of Michigan supported the bi-partisan Michigan Senate plan SB 710 to address reform and funding of the Detroit Public Schools in letters to all legislators and the Governor. The House plan protected charter schools and did not have adequate funding. Unfortunately, the House plan prevailed.

<u>Reading bill</u> - Governor Snyder signed HB 4822 that would require students not reading at grade level in third grade to be held back a year (with some exceptions) and requires schools to implement reading assistance programs. Parents would have the right to appeal to a school administrator not to have their child held back, a major revision from the original bill. AAUW of Michigan opposed retention but eventually backed the Senate version of the bill in communications to legislators and the Governor.

<u>Common Core</u> - AAUW of Michigan put in a card opposing SB 826 of 2016 abolishing Common Core standards and replacing them with the standards Massachusetts used to benchmark their K-12 students in 2008. The bill was reported out of the Senate Education Committee in 2016 along party lines, but saw no further action last session.

In this session, the 2017 House Committee on Michigan Competitiveness and Senate Education Committees have held many hearings on education reform issues in the first few months of this legislative session. At issue have been repeal of Common Core State Education Standards in HB 4192, low-performing school closures in SB 27, and school accreditation standards in SB 174.

AAUW of Michigan sent a communication to the House Committee on Michigan Competitiveness reiterating our national AAUW's statement on Common Core.

#### **ECONOMIC EQUALITY**

<u>Pay Equity</u> – There was no movement on the 11 bills in the House and 4 in the Senate related to pay equity during the 2015-16 legislative session.

Twelve identical bills in the House and Senate were introduced in the new session on April 25, 2017. I wrote the first draft of a new bill to prohibit a salary question in the hiring process. The other new bill increases the penalties for a wage discrimination violation and clarifies that a violation begins from when an employee first becomes aware of the pay discrimination.

Because the House and Senate were on district work on national Equal Pay Day, April 4, 2017, we had our Equal Pay Legislative Day on April 25. The 18 organizations making up the Equal Pay Coalition ably led by AAUW member Mickey Edell had an Issues Briefing at Central United Methodist Church in the morning, a 12:30 Rally on the Capitol Steps, and lobbying the House at 1:30. We got good TV coverage.

<u>Paid Sick Time</u> - The AAUW of Michigan Board endorsed the Time To Care Coalition's petition drive to put an initiated law concerning earned paid sick time on the ballot. The Coalition suspended signature gathering last year but has announced an intent to try again for the 2018 ballot.

#### **INDIVIDUAL RIGHTS**

<u>State ERA/Constitutional Equality</u> – HJR GG to add "sex" to the protected classes in the equal protection clause of Michigan's Constitution that I developed received one hearing in House Judiciary Committee in 2016 at which I testified on our behalf. There was no further action on the measure.

<u>DV and SA bills</u> – On May 3, the Governor signed four bills related to greater protections for sexual assault or domestic violence victims. Public Act 93, 94, 95 and 96 of 2016 provide greater protections for survivors during adjudication processes.

<u>Human Trafficking</u> – Human trafficking related bills HB 5542 – 5544, were passed in the Senate and signed into law during Lame Duck 2016. HB 5838 and HB 5839, which would create a new crime of knowingly selling or offering to sell travel services for the purpose of prostitution or human trafficking passed the Senate during Lake Duck and have been signed into law.

<u>Fetal Tissue Transport bills</u> – In response to a heavily-edited video purporting to show that Planned Parenthood clinics were attempting to sell the remains of aborted fetuses, two bills to criminalize receiving payment for transport of fetal tissue, SB 564 and 565, were passed by the Senate on Michigan Right to Life's Lobby Day. The AAUW of

Michigan testified against the bills in Committee and sent a letter of opposition to the full Senate. Subsequent House amendments defanged the legislation by exempting labs and hospitals from the scope of the law. The Governor signed the bills.

<u>Coercion bills</u> - I testified on our behalf against HB 4787 and 4830, the anti-abortion coercion bills that have, in other states, resulted in crisis pregnancy centers using the information they gather from pregnant women to interfere with the pregnant female's subsequent reproductive choices. Unfortunately these bills became law on June 8, 2016, reflecting the anti-abortion majority in our Legislature.


Reproductive Rights – In 2017, bills to prohibit the state from contracting with organizations that provide abortions have been introduced (HB 4221, SB 162). A bill to create a Choose Life license plate to raise money for Right To Life of Michigan projects, SB 163, has been reported out of Committee and will likely see Senate approval as it was approved last session. I testified against the bills on our behalf. A bill requiring surgical abortions be performed in a freestanding surgical outpatient facility and establishing a fund to privately finance inspections was introduced (SB 164). HB 4467 would require doctors to determine if there is a detectable fetal heartbeat via an ultrasound before performing an abortion.

On the proactive side, a bill to require reimbursement for dispensing a 365-day supply of covered prescription contraception (HB 4019) has been introduced. Bills to exempt feminine hygiene products from sales and use taxes, SB 91, SB 92, have been reported out of the Senate Finance Committee. AAUW of Michigan testified in support of the bills.

#### 99<sup>TH</sup> LEGISLATURE

The Michigan House has 42 new members and there is 1 new Senator. The November 2016 election kept the partisan split in the House exactly the same as the 98th Legislature. There are 16 Republican women in the House and 15 Democratic women of 110 Representatives.

#### **Technology/Website**

The Technology/Website Director's primary responsibility is to oversee the strategic planning, development, execution and implementation related to the AAUW of Michigan website and social media platforms, and to provide website and social media assistance for our branch affiliates. During the 2016-17 term, I worked with the state board to devise a strategic direction, budget expenditures and oversight of our web services; utilized my knowledge of web technologies, content management and best practices, to maintain, monitor, and help position our website as a high quality, secure and cost effective online resource.

#### Goals achieved in 2016 include:

- Refreshed website homepage and web page designs.
- Moved site to Cloudflare, a service that speeds up and protects internet properties from large attacks on their DNS system.
- Subscribed to G-Suite from Google Cloud (formerly Google Apps for Work and Google Apps for Your Domain) and Skype for Business.
- Reduced state board travel and hotel expenses encouraging and facilitating the use (including training) of online video conferencing (i.e., Hangouts on Air and Skype for business).

The AAUWMI state board held its January and April board meetings using YouTube Live with Hangouts on Air and Skype for Business. The apps allow up to 25 people to participate interactively. Cost for use the two apps: \$17.50/month.

The group varied in age, culture, and experiences which brought insights into their leadership discussion.

At this time Diversity and Inclusion is also working on "What Does Diversity Look Like to Your Branch?" This presentation will be a tool for branches in all of Michigan's regions to more readily understand the broad definition of diversity in our organization and understand how to apply it to their own location. This will be ready to roll out to branches at the beginning of the new fiscal year.

As well as the Toolkit from AAUW National, members of National's task force and our Diversity and Inclusion Director are always good resources as well. AAUW of Michigan Diversity and Inclusion director is, like all AAUWMI board members, available for consulting and even branch visits.





#### SPEECH TREK, 2016-2017 ANNUAL REPORT

AAUW of Michigan's Speech Trek is designed to help high school students develop public speaking skills and knowledge about public policy issues. Kim Glanville, Iron Mountain-Kingsford Branch finalist, is our 2017 Speech Trek Grand Prize Winner. AAUW of Michigan extends congratulations to Kim and wishes her continued success in future academic and leadership endeavors.

This year, students were asked to address: "Title IX: More Than Athletics." The M. Jean Jokipii Memorial Speech Contest requires students to present an original five- to six-minute speech using the extemporaneous mode of delivery. Students may only use one 4" x 6" note card and prompting is not allowed. The students take a stand on a Title IX issue, thoroughly research the issue, and present it in an impassioned, concise, convincing manner. A panel of distinguished judges evaluates and scores contestants' speeches. Using a point system (0-20), three areas are judged and scored: Content, Organization and Delivery. The contestant with the highest average score is declared the grand prize winner.

AAUW of Michigan applauds the work of Kim Glanville. We hope she will continue to raise her voice on Title IX and other issues that impact her life. #### Warrior Women Coalition Scholarship for Inclusion (2016-17) FUNDED!

Our organization has noticed a lack of diversity in our ranks after graduation. We recognize and acknowledge that this lack exists, in part, to a dearth of support systems and opportunities in place for women and nonbinary people in lower socioeconomic stratifications. We consider it our responsibility as an organization and a community to provide more opportunities and supports for our peers in pursuit of higher education. We invite you, our fellow students and mentors, to join us in empowering other members of our communities at a time when many students leave our campus due to financial difficulties.

Our goal was to create a modest scholarship for students who demonstrate financial need and experience life at some other intersection of marginalized identity, including but not limited to race, religion, sexual orientation, and ability. Since we are students, and we anticipate many of our donors being students, we are only requesting minor amounts, and our initial goal is small.

We raised \$500 to issue two small \$250 scholarships, to be applied for the Winter 2017 semester. Any and all women and nonbinary people may apply, providing they are (1) Wayne State students, (2) have been a responsive participant in the AAUW: Warrior Women Coalition for one semester, (3) demonstrate financial need, and (4) experience marginalization at some other intersection of social identity. Applications will consist of a series of short essay questions and will be scored blindly. Any excess of our \$500 goal would go directly toward increasing the number and amount of scholarships to be awarded.

At the time of this publication many of the students had graduated and moved on to other endeavors. However, their stellar work during the 2016-17 program year deserves to be recognized and recorded. Michigan For Public Education (formerly the Michigan Public Education Task Force) is a nonprofit, nonpartisan organization comprised of individuals and organizations advocating for and promoting public schools.

#### We vow to:

- Uphold Article 8, section 2 of the Michigan Constitution which states: "The legislature shall maintain and support a system of free public and elementary schools as defined by law. Every school district shall provide for the education of its pupils without discrimination as to religion, creed, race, color or national origin."
- Preserve the First Amendment separation of religion and state in the public schools.
- Defend public education when it is wrongly attacked. Present a truthful understanding of public schools through the use of relevant and accurate data.

The membership consists of organizations and individuals who support the purpose of MFPE. Each member organization shall appoint a representative to attend meetings and report activities to its membership.

MFPE meets quarterly on the first Friday of the month from 1:00 p.m. to 3:00 p.m. Meetings alternate between the National Council of Jewish Women (NCJW) Greater Detroit Section in Southfield, the Michigan PTSA and MASB Board room in Lansing, The Michigan Education Association Building in East Lansing, Michigan and the Michigan Elementary and Middle School Principals Association offices in Mason, Michigan.

MFPE membership includes access to the MFPE Listserve. You can find more information about MFPE on the Website at www.mfpe.net.

This year in MFPE there has been considerable discussion about the future of public education in Michigan. The membership in MFPE has begun to disappear and it makes it difficult to make serious decisions about important matters when the leadership isn't there. There has been discussion about the new Education Secretary in Washington and the impact she might have on the future of public education, not only in Michigan but the entire United States. There has been some movement in joining other groups in Michigan that are concerned about public education. It is important that everyone that is involved or concerned with public education keep themselves apprised of what is happening around the country.

#### COUNCIL ABOUT PAROCHIAID (CAP) 2016-2017 ANNUAL REPORT

The Council of Organizations and Others for Education about Parochiaid (CAP) has a website (<a href="www.capmichigan.org">www.capmichigan.org</a>) where the history of the council is described in detail. CAP became active in Michigan politics during the 1970s and is comprised of representatives of child advocacy, civil rights, and education groups supporting the constitutional guarantee of a free public education for all Michigan children. Because AAUW supports public funding for public education and supports the separation of church and state in public education, a close tie has existed since the council was first organized.

At each quarterly CAP meeting there is a Legislative Update prepared by Capitol Services and reported to the members in attendance. Following the meeting, the legislative report is posted on the CAP website for the benefit of individuals interested in the separation of church and state issues in public education. The Director of Operations from Capitol Services emails several weekly updates that address education and legislation.

The CAP Board of Directors is made up of four elected officers and four At-Large Directors. The two year terms of office began June 1, 2016. The elected officers are Interim President Lois Lofton Donover (AFT Michigan), Vice-President, Lois Lofton Donover, Rod Monts (ACLU) and Secretary, Mickey Edell (AAUW) Treasurer. In addition the At Large Directors are Nancy Knight (Michigan Education Association), Paul Liabenow (Michigan Elementary and Middle Schools Principals Association), Jennifer Smith (Michigan Association of School Boards), and Ben Kefgen (Michigan Association of Secondary Principals.) Meetings are held quarterly that alternate between Lansing and Southfield.

This March CAP and a coalition of education and parent groups filed a lawsuit to stop state funding to private schools.

Because of the November 2016 elections CAP conducted a Candidate Questionnaire in the fall. The polling included a number of candidates running for political office. The questions were asked to ascertain each person's stance on funding for parochial/religious schools. The questions were as follows:

- 1. Do you support or oppose using public funds, either directly or indirectly, for payment, credit, tax benefit, exemption or deductions, tuition voucher or subsidy, grant or loan to support attendance of any student at K-12 parochial/religious schools?
- 2. Would you support or oppose amending the Michigan Constitution to permit or allow the use of public funds for payment, credit, tax benefit, exemption or deduction, tuition, voucher or subsidy, grant or loan to support the attendance of any student at a K-12 parochial/religious school.

Michigan ERAmerica continued advocating for ratification of a federal Equal Rights Amendment in various ways.

After years of effort from ERA supporters here in Michigan and across the nation, we are thrilled to report that Nevada became the 36<sup>th</sup> state to ratify the ERA on March 22, 2017. This victory would not have been possible except for determination of ERA activists in both ratified and unratified states to keep the dream of Constitutional Equality alive.

This session of Congress, Michigan ERAmerica lobbied our Congressional Delegation in support of the Three-state Strategy that would eliminate the deadline on the 1972 ERA. This would allow three more states to ratify and thereby be added to the 35 states that have already ratified. If accepted by Congress, these ratifications would make the ERA part of the Constitution. It is this premise that lead to the Nevada ratification.


Both Senators Debbie Stabenow and Gary Peters have co-sponsored the Three-state Strategy ERA bill in the Senate. The following Michigan Representatives are co-sponsors of the companion bill in the House: John Conyers, Debbie Dingell, Dan Kildee, Brenda Lawrence, and Sander Levin.

Michigan ERAmerica also gave monetary support to ratification efforts in unratified states.

Here in Michigan, we published the Coalition Update, a newsletter that keeps our members informed on ERA activity in Congress and in the states.

We partnered with the League of Women Voters of NW Wayne County to distribute ERA pamphlets to students at Schoolcraft Community College during two school fairs where the LWV registered voters.

We also cosponsored an annual Women's Equality Day Luncheon with AAUW of Michigan in August 2016. An ERA update was presented to those in attendance and former Michigan Representative Maxine Berman was the main speaker. A luncheon is planned for this year on August 26, in Livonia. 
